Planning Your Legacy: Steps to Consider

1. Consider leaving some for your loved ones

If you have dependents or family members, we recommend you leave something for them in your Will. Make sure they are not disadvantaged by your gifts to FEBC Australia or other charities.

2. Consider a gift for FEBC Australia – see below for the type of gifts.

3. Talk to your loved ones about your decision.

We encourage you to share why leaving a gift for FEBC Australia (and other causes close to your heart) is important to you.

4. Seek legal advice when preparing your Will.

5. Let us thank you and honour your legacy.

If you've included FEBC Australia in your Will, letting us know gives us the opportunity to thank you and talk with you about how your legacy might be remembered. If you prefer not to share this, we fully understand.

Choose a type of gift

Your gift to FEBC Australia could take one of the following forms:

- A specific amount of money
- Specific assets (e.g. shares, property, life insurance policies)
- A percentage (%) of the residue of the estate
- The residue of the estate (after other gifts are made)

NOTE:

If you own an investment asset, such as shares or rental property, it may be subject to Capital Gains Tax (CGT) when passed through your estate. However, if you leave that asset to a charity with Deductible Gift Recipient (DGR) status, the CGT liability is removed.

You can name either of our two registered entities as a beneficiary in your Will. **Far East Broadcasting Co (Australia)** is our main entity and does not hold Deductible Gift Recipient (DGR) status. FEBC Relief Limited, focused solely on aid and welfare work, does have DGR status.

In most cases, naming FEBC Relief Limited ensures your gift is received in the most tax-effective way. Your lawyer can ensure the correct entity is named and advise on the best approach if you wish to include investment assets in your Will.

State the correct name of FEBC entity. You can name either of our two registered entities as a beneficiary in your Will.

6. Consider engaging our Bequest partner to write your Will for free.

Including a Gift in Will to FEBC Australia

To ensure your client's gift has the greatest impact, we recommend a general gift rather than a restricted one. This allows FEBC Australia flexibility to direct the gift to where the need is greatest at the time.

Suggested Legal Wording for Your Client's Will
